Menu Description:

- Vendors must obtain a temporary Health Permit if they don't have a current annual State Health Permit. Health permits are required and will be reviewed by the Health Department.
- Each vendor will receive 4 tickets to the festival.
- A Taste of New Kent Festival Committee reserves the right to deny any application without explanation. Vendor applications not accepted will have their checks returned.
- All applications must be submitted with full payment. Incomplete applications will not be accepted.
- No political advertising allowed.
- Setup will be from 8:30 A.M.-10:45 A.M. All passenger vehicles must vacate the vendor areas no later than 10:45 A.M. No personal vehicles are allowed on site during festival operating hours. There will be a designated vendor parking area. No vendor may breakdown until 6:00 P.M.
- Food trucks will be directed to a designated space assigned by the Event Coordinator.
- Collecting and reporting of Virginia State Sales and Use Tax is the responsibility of the vendor.
- Absolutely NO PETS allowed on festival grounds.
- No sharing of booth space.
- The festival will not be postponed or cancelled because of bad weather. Vendors should be prepared for any weather. All vendor space will be on paved surfaces.
- All exhibitors and assistants must follow festival rules.
- Vendors are only to use the space they have rented. Extending beyond the boundaries of your rented space could result in additional fees and/or expulsion from the festival.
- No product or service bearing the "A Taste of New Kent Festival" name or logo, or the name and logo of any of its sponsors, may be sold or marketed in any manner without prior written consent from the festival or the sponsor.
- No electricity is available.
- Vendor trash must be taken with them or placed in a trash receptacle.

Submission of this application, VALID for current year only, signifies your understanding and acceptance of and agreement to abide by the Application Agreement of A Taste of New Kent Festival if invited to participate. The Festival reserves the right to accept or reject any new or returning exhibitor. By signing this form, I agree that I have read, understand and will abide by all guidelines.
